Additional Notes

In order to ensure correct operation of the Ontrack PowerControls Administrative Server and any Ontrack PowerControls for Exchange and Ontrack PowerControls ExtractWizard clients, firewall solutions must be configured to allow communication on the TCP port OAS. The TCP port number can be configured via the Management Console.

Windows-based domain/forest network environment

The system running OAS, and all systems running Ontrack PowerControls and Ontrack PowerControls ExtractWizard, must be joined to the same Windows-based network forest. Users must be logged in as a user of that domain when running Ontrack PowerControls. To ensure correct operation, the OAS Administrator should be logged in as a domain user with Administrator rights on the local system running OAS, in order to install and configure OAS. The

domain account will also need authority to update Active Directory (e.g. Domain Admin), if you wish to advertise OAS services on Active Directory. During installation, the user name and password of a domain account with the necessary rights to access the Global Catalog and Active Directory will need to be entered to ensure the OAS Windows service is able to operate correctly.

Installing Ontrack Administrative Server

Before you install OAS, you should consider your installation strategy, including the availability of OAS around the clock, the security OAS will be providing and how your installation location could impact the level of security, and your available resources for application installation.

Installation Recommendations

Availability: You should install OAS on a distinct machine from Ontrack PowerControls. OAS is a server and should be available 24/7. If OAS is not available, Ontrack PowerControls and Ontrack PowerControls ExtractWizard will not function. A workstation with these applications running is far more likely to be rebooted in the course of normal work and shutdown overnight. OAS can be run on a Microsoft Exchange Server, but because a Microsoft Exchange Server is a mission critical system, especially for larger organizations, it isn't recommended but is still up to you to decide.

Security: OAS is the provider of security related services (auditing, mailbox permissions, and centralized settings), so it would be the best practice to separate the user and Administrator roles. Running Ontrack PowerControls and OAS on the same system could compromise the integrity of the security provided by mailbox permissions and auditing functions. However, if the Administrator of OAS is also a user of Ontrack PowerControls, having them both installed on the same machine makes sense.

Resources: OAS is a server and needs sufficient resources to run efficiently. If your organization needs to run multiple installations of Ontrack PowerControls simultaneously, having a dedicated, server type system would service client requests more efficiently. Attempting to run OAS on a system running other applications, such as Microsoft Exchange Server or Ontrack PowerControls, could result in compromised or slower performance.

Upgrading Ontrack Administrative Server

OAS 9.1 will not upgrade existing earlier installations of OAS. Manually uninstall previous versions before installing OAS 9.1.

Limitations

In cases where the Ontrack Administrative Server is stopped and an application or service started that uses the TCP port OAS is configured to use, OAS will automatically change the TCP port to avoid a conflict. In this situation, clients will fail to connect. If Active Directory advertising is in use, the OAS Administrator must stop and then start Active Directory advertising via the Ontrack Management Console to allow clients to automatically connect. If Active Directory advertising is not used, clients must update the server address to use the new TCP port.

On Windows Vista and later operating systems the Ontrack Management Console should be started with Administrator privileges to ensure correct operation. This can be achieved by selecting the 'Run as administrator' option in the context menu for the Ontrack Management Console shortcut in the Start menu or desktop. Failure to run with Administrator privileges may result in problems when configuring the administrative server and mailbox permissions rules.
